Frac Blinebry-Tubb-Drinkard perfs 5054'-5930' w/ 92,500 gal 25# x-linked gel and 220,000# 20/40 Brown Sand at 40 BPM down 3 1/2" tubing. CO frac sand w/ bailer. Run prod equip. Put well back on pumping production.
