RIH with 118 JTS and PKR. Set PKR @ 3695' tested casing to 400 PSI for 30 Min. Ran chart recorder (see attached chart). Verbal approval was given by Sylvia Dickey with the NMOCD and Pat Hutchings with the BLM signed the chart. The well was returned to Injection.
