Dump bail 20' cement on top of CIBP (TOC at 3914'). Circulate well with 100 bbls. 10# packer fluid. NU WH. Load hole x pressure test well. RD x MO x clean location.

Well is now temporarily abandoned.

After 12-15-08 the well must be online or plans to P & A must be submitted.
