Frac Blinebry-Tubb-Drinkard perfs 5054'-5930' w/ 92,500 gal 25# x-linked gel and 196,360# 20/40 Brown Sand and SiberProp resin coated sand at 40 BPM down 3 1/2" tubing. CO frac sand w/ bailer. Run prod equipment and FG rods. Put well back on pumping production.
