Yates Petroleum Corporation respectfully requests a variance to test the BOP on surface casing to 1000psi using rig pumps.

The variance for testing of the BOP/BOPE on the surface casing to 1000 psi is not approved since MASP for the next hole is approximately 1300 psi. Rig pump use for tests above 1000 psi will not be approved due to the inaccuracy of rig pump pressure readings and safety concerns when exceeding 1000 psi.
