On behalf of Sahara Operating Company as Obligor, we Community National Bank, (hereinafter referred to as "bank"), hereby establish an IRREVOCABLE LETTER OF CREDIT (LOC) in favor of the Bureau of Land Management (BLM) and agree to immediately pay upon demand by and to the Department of the Interior (BLM), the full amount of TWENTY-FIVE THOUSAND AND 00/100 DOLLARS (\$25,000.00) upon receipt of a written demand therefore by the Authorized Officer (AO) of the BLM retaining the personal bond of the Obligor whose bond this letter serves as security pursuant to 43 CFR Section 3104.1.

This LOC is effective the dated <u>filed</u> with BLM and will expire exactly one year from the dated <u>filed</u>. This credit will automatically be extended for periods of (one year or such longer periods as may be determined by the bank) from any such scheduled expiration date as originally scheduled or as automatically extended by this provision.

In the absence of a notice from the bank to the AO from at least 90 days prior to the stated or any extended expiration date, not to renew the credit represented by the LOC, the LOC will be automatically renewed in full force and effect for an additional one year period. Non-renewal notification will be sent to the AO by Certified Mail Return Receipt Requested.

Upon receipt by the AO of a non-renewal notice from us, the AO may draw on us for up to the amount of this LOC, prior to the expiration thereof, provided that such draft is accompanied by a statement signed by the AO to the effect that no satisfactory replacement bond has been provided by the Obligor prior to 30 days before this LOC expires, pursuant to 43 CFR 3104.1 (c) (ii).

It is also understood that, at any time this LOC is in effect, the AO may draw on this LOC for any amount, up to the full amount to cover any default in obligations covered by the bond, including but not limited to, rentals, royalties, and appropriate reclamation of lands associated with development of oil and gas in any leases(s) to which the bond applies.
