6/13/08 Tag plug @ 1500'. POH to 400'. Spot 25 sx, class C cement. POH w. tbq. Perf. csg. @ 150;/ Set packer @ 30'. Sqz. and circulate 45 sx class C cement to surface. Spot 10 sx class C cement from 30 to surface. Cut off wellhead and Weld on Dry hole Marker. Rig down.
