13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. All surface piping and debris will be removed from location; a Dry Hole Marker will be installed according to BLM provisions; the caliche on the location will be pushed to two sides, 3 feet of underlying topsoil will be pushed to two opposite sides, caliche will be pushed into excavated area, 3' of excavated topsoil will be pushed into excavated area covering the caliche and contoured to grade; the road to the north will be flipped and buried in the same manner; a 2-3' berm will be constructed on the north end of the road to block access after reseeding; reseeding of the location and road will be in accordance with BLM approved methods and grass mixes; BLM will be notified at least 24 hrs before any operations commence; BLM will be notified when completed for inspection

Private surface, consult landowner (PLO) prior to start. Remove any/all contaminants. Contour the location to blend with surrounding landscape. Rip and seed with PLO mix or #2 mix.
