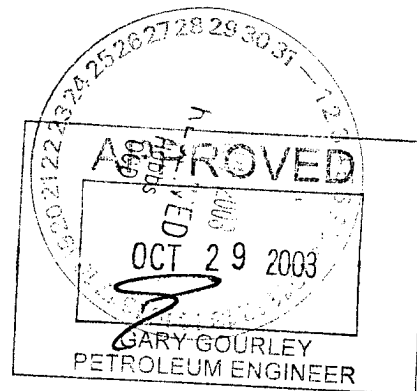

P&A Procedure:

- Set CIBP @ 12200' w/ 25 sx cement on top
- Spot 40 sx of cement from 9100' to 9200'
- Spot 40 sx of cement from 6700' to 6800'
- Cut 7" casing @ freepoint and recover casing
- Spot 45 sx of cement from 50' in and 50' out of 7" casing stub. Tag.
- Spot 75 sx of cement from 5137' to 5037'
- Spot 55 sx of cement from 3100' to 3200'
- Spot 55 sx of cement from 1350' to 1450'
- Spot 55 sx of cement from 560' to 660'. Tag.
- Spot 25 sx of cement from surface to 50'
- Cut off wellhead and weld on PA marker. Clean and restore location.
