Complete MIT, purpose is to verify well bore integrity. Base on positive test we will submit procedures to rework & re-activate well.

- Wire line company to move on site.
- Water truck on site.
- Run wire in hole to test TD & verify.
- Fill bore with fluid, pressure up & test for leaks.
- Verify casing integrity.
- Move off well site
- Estimated time for procedure is 1/2 day.
