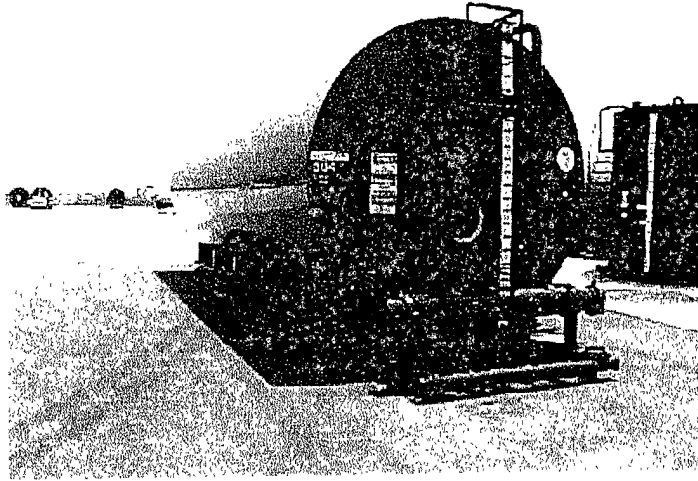

1. The above is a picture of the type of steel tank to be used during workover operations.
2. A steel flow line will be laid from the wellhead to the steel tank.
3. Fluids from the wellbore will be circulated from the wellbore to the tank to spot acid.
4. Flow of water, oil, or gas by natural flow, swabbing, or rods pumping will be direct to the steel tank for testing purposes.
5. If a reportable spill should occur it will be reported to the NMOCD and the land owner and remediated as to NMOCD guide lines and rules.
6. Water, spent acid water and produced water will be trucked to Sundance Services (Permit No. NM-01-0003) for disposal. No solids are anticipated.
7. Oil from the steel tank will be skimmed off and transferred to the tank battery by vacuum truck.
