Saber Resources plans to close four open drilling pits in Lea County, NM. Saber Resources received a "Letter of Violation" dated May 21, 2008 from the NMOCD for the "J W Houston B #1" well site which had an open workover pit. Saber Resources hired Elke Environmental to close the pit, and in the process of site evaluation discovered three more open workover pits. The three open workover pits are the Liberty #1, Glad Wallace #3 and Wallace #1. Saber Resources hired Elke Environmental to close these pits as well. Attached is the C-144 for the pit closures and all historical data recorded since the previous operator applied for the APD. Re: Closure Plan for Saber Resources – J W Houston B #1

Mr. Larry Johnson,

The proposed closure for the above well is waste excavation and removal. All excess fluids will be removed and disposed at a division-approved facility. The drilling mud and liner will be excavated and hauled to Gandy Marley Disposal (Permit # NM-01-0019). After all drilling mud and liner have been removed, the pit bottoms will be sampled in five points and analyzed for TPH 418.1, total BTEX, Benzene, Chlorides and the DRO and GRO combined fractions. The levels will not exceed 0.2 mg/kg of Benzene, 50 mg/kg of total BTEX, 500 mg/kg of TPH 418.1, 250 mg/kg of combined fraction GRO/DRO, 250 mg/kg of Chlorides. If samples exceed these levels a C-141 will be submitted.

Once backfill is approved the site will be backfilled with clean native soil and a minimum of 1' of topsoil will be placed on the site to promote revegetation. The site will be reseeded with BLM Seed Mixture #3. A final report will be attached to the Final C-144 once closure is commenced.
