The EBDU #34 was previously temporarily abandoned with Blinebry perms fr/5807-5982' and a CIBP @ 5750'.

Apache attempted to reactivate this well via the following procedure:

7/18/08 Drilled out CIBP @ 5750'. Ran bit and scraper to PBTD @ 5990'.

7/22/08 Acidized existing Blinebry perms fr/5807-5982' w/ 4000 gals HCl.

7/23 - 7/27/08 Swabbed Blinebry and found to be uneconomic.

7/28/08 Set CIBP @ 5750' w/ 20' cement.

8/21/08 Ran MIT Test and Passed. See attached chart. Original sent to OCD Hobbs.

At this time, Apache would like to request a 6 month extension of the TA status in order to prepare this well for conversion to injection. The EBDU #34 will help support production in two existing offset producers (EBDU #33 & #35) and two new producers to be drilled in the 3rd Qtr of 2008 (EBDU #90 & #92).

The EBDU #90 is expected to spud on or about August 28, 2008 and the EBDU #92 should spud approximately one week later on September 5, 2008. Following completion of these two new wells, Apache plans on converting the EBDU #34 to injection pending NMOCD approval. Apache anticipates the conversion to begin on or around November 1, 2008. Paperwork for the conversion has been prepared and was submitted to the NMOCD on 8/19/2008. Legal notice was published in the Hobbs News Sun 8/20/2008.

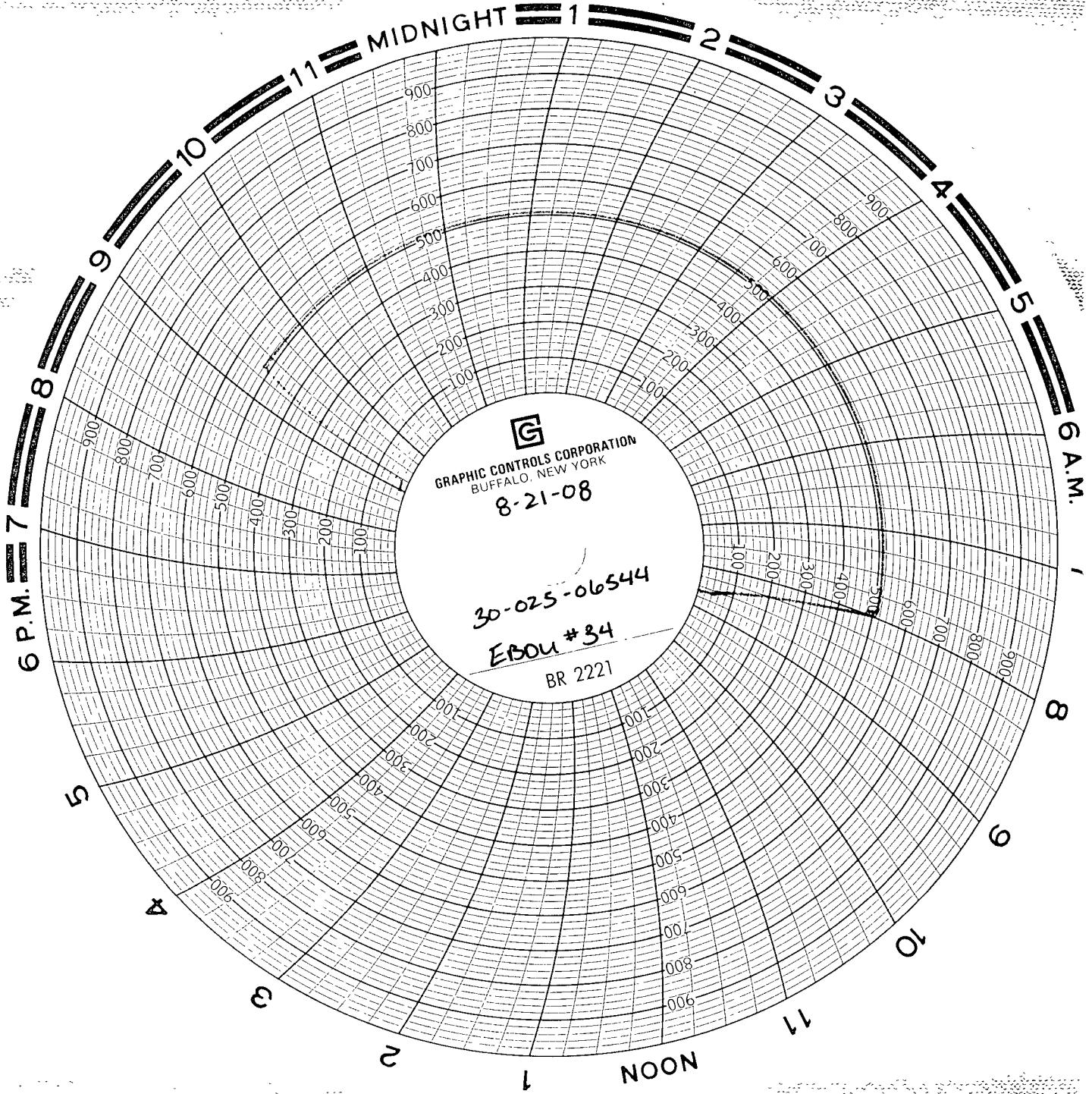
