Apache has received verbal approval from BLM engineer Wesley Ingraham for a 3 month extension to the TA status on this well. Previous plans were to P&A this well, but due to positive results from the reactivation of the EBDU #54 which offsets the EBDU #39, Apache plans to reactivate this well. This 3 month extension to the TA status will allow Apache time to perform the work and report production to the state.
