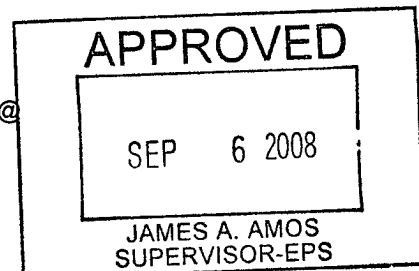

Dump bail 35' cement on top of RBP @ 8950', then set CIBP @ +/- 6900'. Perforate the Tubb @ 6375-6380' & 6615-6620' w/4 spf, then acid stimulate.

Work to include the use of steel pits, therefore, a pit permit will not be applicable.
