Reclaim location and access roads

1. Remove caliche pad and roads.
2. Remove all contaminated soil average 4-6' deep. Deliver to CRI landfill.
3. Replace with 3' caliche barrier, level and compact.
4. Put in 2' - 3' topsoil cap on entire location, level and shape to natural.
5. Build earthen berms on entrances to prohibit vehicular traffic.
6. Seed all disturbed areas with BLM # 2 seed mixture with approved seed.

Met with BLM Agent, Trish Badbear, for procedures and guidelines before starting job. Job complete on 8-5-08. Trish Badbear was present at the job completion for job and approval and to witness seeding.
