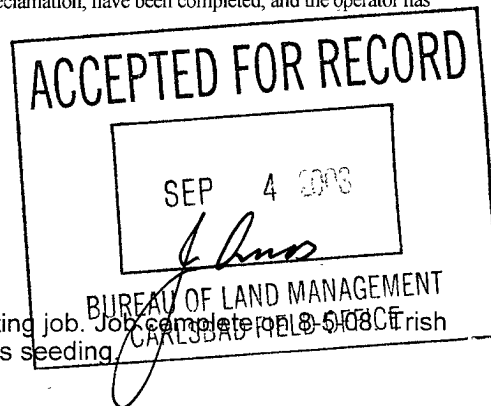

13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Reclaim location and access roads

1. Remove caliche pad and roads.
2. Remove all contaminated soil average 4-6' deep. Deliver to CRI landfill.
3. Replace with 3' caliche barrier, level and compact.
4. Put in 2' - 3' topsoil cap on entire location, level and shape to natural.
5. Build earthen berms on entrances to prohibit vehicular traffic.
6. Seed all disturbed areas with BLM # 2 seed mixture with approved seed.

Met with BLM Agent, Trish Badbear, for procedures and guidelines before starting job. Job complete on 8-5-08. Trish Badbear was present at the job completion for job and approval and to witness seeding.
