Flush w/1000 gal 15% HCL + 2024 gal linear gel. RIH w/CBP & set @ 6190'. Perf @ 5940'-6140', 2 SPF, 32 holes. Acidize w/2500 gal 15% HCL. Frac w/52,668 gal 22# Lightning; 47,500# 16/30 Ottawa; 19,500# 16/30 SiberProp. Flush w/2850 gal linear gel. Well started flowing RDMO.
