01.21.08 Pressure tested surface casing to 1000 psi for 30 minutes.

01.28.08 In 12¼" hole, ran 9¾" 40# J-55 LTC to 5386.' Cemented with Lead 1650 sx Interfill C + 0.125# Poly-e-flake (wt 11.9, yld 2.45) and Tail 200 sx Premium Plus + 1% CaCl₂ (wt 14.8, yld 1.33). Circulated 674 sx to surface. WOC 22 hrs.
