NEED TO INSTALL NEW WELL SIGN AT WELL AND BATTERY (SEE RULE 103) AND REMOVE SURPLUS EQUIPMENT AND DEBRIS FROM LOCATION. (GENERAL HOUSEKEEPING RULE 114). 1st letter of non-compliance. MW

ALSO NEED TO DISCONNECT BLOWDOWN LINE AND REMOVE (RULE 116). 1st letter of non-compliance. MW

Comments on Inspection: Pumping unit on well with Ajax engine. Stackpac and dehydrator unit south of well. Location need attention. Drums and plastic oil containers scattered around location. Rods and tbq on ground north of well. Well sign not legible. NEED TO REPLACE WELL SIGN (RULE 113) AND REMOVE ALL SURPLUS EQUIPMENT, CHEMICAL DRUMS AND DEBRIS FROM LOCATION (GENERAL HOUSEKEEPING RULE 114). MW						

In the event that a satisfactory response is not received to this letter of direction by the "Corrective Action Due By:" date shown above, further enforcement will occur. Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well. Such a hearing may result in imposition of CIVIL PENALTIES for your violation of OCD rules.

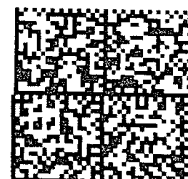
