Apache Corp took over operations of the Stevens B #9 from John H Hendrix Corp effective 3/1/2008. This well is temporarily abandoned. Apache proposes to recompleate this well and return it to production in compliance with the BLM's mandate. Apache proposes to recompleate this well via the following procedure:

1. MIRU pulling unit.
2. Run bit and scraper to PBTD @ +/- 3570'.
3. Run cased hole logs for engineer evaluation.
4. Perforate Tansill Yates formation.
5. Acidize and fracture stimulate Tansill Yates formation as needed.
6. Install production equipment.
7. Put well on production from the Tansill Yates.

Apache has applied for administrative approval of simultaneous dedication from the NMOCD and is awaiting approval before beginning this work. Apache is requesting that the TA deadline be extended an additional six months in order to obtain this administrative approval and complete the work. This well was pressure tested 8/28/08 and passed. See attached chart. Original sent to NMOCD.
