To return this well to active production we MIRU Well Service Unit. Pull off WH & put on BOP. Ran in hole w/4 3/4" tooth bit & tag CIBP @ 3576'. Drill up CIBP & clean out to 3632'. Started losing returns. POOH w/bit & RIH w/ Mud anchor and 2-3/8" tubing. Strip off BOP & Flange up WH with bottom of mud anchor @ 3608'. Built production manifold and hooked to unit system. RIH w/ 2"X 1.5" X 16' RHBC insert pump and 7/8" rods and hung well on pump unit. Well production started 8/9/2008 and well is making 1/2 BOPD, 100 BWPD, & 0 MCFD. RDMO WSU.
