2) Plug back to 4140' with sand/gravel.
3) Run CICR x squeeze from 4060' - 4140' per Halliburton recommendation.
4) Drill out to 4135'.
5) Pressure test casing to 1000 psi. If holds, clean out to PBTD at 4263'; if not, discuss options with engineer.
6) Set packer at 4145' x treat perfs at 4157' - 4174' and 4203' - 4255' with 1000 gal. 15% HCL (max. rate 3 bpm, max. press. 2500 psi).
7) RIH with isolation packers - set bottom packer at 4140' and upper packer at 4025'.
8) RBIH with 2-7/8" duo-line injection tubing.
9) Pressure test well x chart for the NMOCD.
10) ND BOP x NU WH. RD x MO x clean location.
