DESIGN PLAN

Fluid & cuttings coming from drilling operations will first pass over the Shale Shaker with the cuttings going to the CRI haul off bin and the cleaned fluid returning to the steel working pits. The fluids from the steel working pits will then pass through a Mud Cleaner and Centrifuge with the remaining solids going into the CRI haul off bin and the clean fluids being reused for drilling operations.

Equipment includes:

- 1 – 500 bbl steel frac tank (Fresh water for drilling)
- 2 – 500 bbl steel frac tank (Brine water for drilling)
- 2 – 350 bbl steel working pits
- 3 – 20 cu yards steel haul off bins (calc'd cuttings are 100 cu yards)
- 2 – Mud Pumps
- 1 – Shale Shaker
- 1 – Mud Cleaner
- 1 – Centrifuge

OPERATING AND MAINTENANCE PLAN

Inspection to occur every tour for proper operation of system and individual components. If any problems are found they will be repaired and/or corrected immediately.

CLOSURE PLAN

All haul bins containing cuttings will be removed from location and hauled to Controlled Recovery, Inc's (#R9166) disposal site located near mile marker 66 on Highway 62/180.
