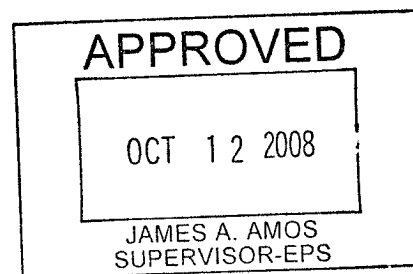

1. MIRU workover rig and flowback tank.
2. POOH and lay down 2-3/8" tubing.
3. Inspect 2-3/8" tubing.
4. Set RBP @ 3050'.
5. Pressure test.
6. RIH with casing gun and perforate the following:
2329', 2418', 2452', 2478', 2576', 2647', 2668', 2740', 2912', 2997', 3026' (11 perms).
7. RIH w/ packer, set @ 2275'.
8. Acidize
9. Swab to recover load.
10. Release packer and POOH w/ tubing.
11. Rig up Frac Valve.
12. Run stimulation job.
13. RIH and tag for fill. (If fill rig up foam unit and clean out to TD).
14. RIH and remove RBP.
15. RIH with production equipment and put well on production.
