RU WL x perf at 4196' - 4204', 4210' - 4220', & 4225' - 4234', 2 JSPF. Set treating packer at 4110' x acidize perfs with 2000 gal. 15% HCL. Circulate well with 150 bbls 10# brine. Run 4-3/4" bit on 2-7/8" workstring x tag at 4328'. Run 5-1/2" Arrow-Set 1X packer on 128 jts. 2-7/8" duoline injection tubing (packer set at 4065'). ND BOP x NU WH. Pressure test casing to 700 psi x 30 min., held (test witnessed). Turn well over to injection. RD x MO x clean location.

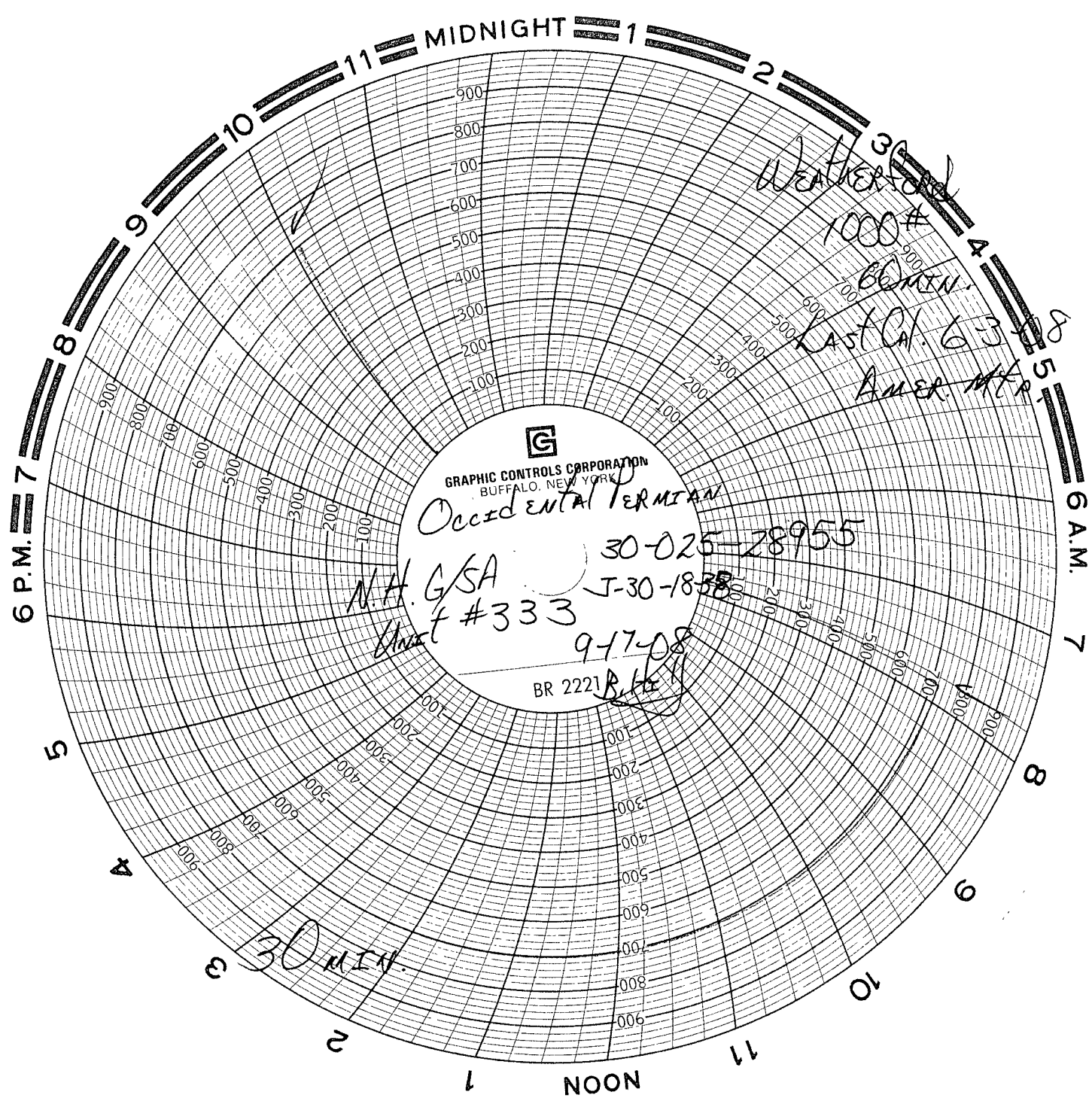
