5. Spot 100sx, plug 2975-2700 (9 5/8 Shoe, Lnr Top, Yates) WOC Tag.
6. Spot 65sx, plug 1300-1100 (T-Salt) WOC Tag.
7. Spot 100sx, plug 450-200 (13 3/8 Shoe) WOC Tag.
8. 10sx Surf, install dry hole marker.
