Fasken Oil and Ranch, Ltd. also request a change of plans on the 8 5/8" intermediate casing to do a two stage cement job.

The two stage cement design is shown below.

Cement Detail

1st stage: 20 bfw, 600 sx HLC with 6# salt, 3# Pheno-Seal (s.w. 12.6 ppg, yield 2.01 ft /sx) plus 350 sx Class "C" with (s.w. 14.8 ppg, yield 1.32 ft /sx).

2nd stage: 20 bfw, 1350 sx HLC with 6# salt, 1/8# Poly-E-Flake (s.w. 12.6 ppg, yield 2.01 ft /sx) plus 300 sx Class "C" with 1% CaCl (s.w. 14.8 ppg, yield 1.32 ft /sx).

If first stage does not circulate, contact BLM prior to pumping second stage. Second stage to circulate.
