Apache proposes to recompleat this well via the following procedure:

1. DO CIBP @ 5980' and CIBP @ 6350'. Clean out well PBTD.
2. Acidize Drinkard fr/ 6400-6630'.
3. Perforate Tubb fr/ 6009-6282'.
4. Isolate and acidize Tubb fr/ 6009-6282'.
5. Commingle Blinbry/Tubb/Drinkard.
6. Install pumping equipment.
7. Place well on production from the previously approved Eunice; Blinbry-Tubb-Drinkard, North (22900).
