1. Remove flow and injection lines.
2. Remove caliche and contaminated soil from location and transport to CRI disposal.
3. Replace with clean caliche up to 2' from surface to form barrier.
4. Cap last 2' with clean topsoil.
5. Level and shape for seeding.
6. Reseed all disturbed areas with BLM #2 seed mixture with BLM approved seeder.

Reclaimed location with BLM recommendations and met with BLM, Trish Badbear, prior to start-up procedures. Reclaim complete on 10-17-08 by McNabb Services. BLM was notified upon completion and seeding for them to witness and approve.
