1. Remove flow and injection lines.
2. Remove caliche and contaminated soil from location and access road and transport to CRI disposal.
3. Replace with clean caliche up to 2' from surface for barrier.
4. Cap last 2' with clean topsoil.
5. Level and shape for seeding.
6. Reseed all disturbed area with BLM #2 seed mixture with BLM approved seeder.

Reclaimed location to BLM recommendations and met with BLM, Trish Badbear, prior to start for procedures. Reclaim completed on 10-17-08 by McNabb Services. BLM was notified upon completion and seeding for them to witness and approve.
