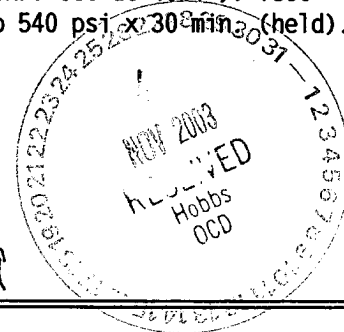

RIH with wireline x set 5-1/2" CIBP at 4251'. RIH with 5-1/2" Guiberson UNI-VI packer on 128 jts. 2-7/8" duo-line tubing (pkr. set at 4044'). Test casing to 1000 psi x circulate with 90 bbls pkr. fluid. Load x test casing to 540 psi x 30 min (held). RD x MO x clean location.
