RU HES x squeeze open perfs at 4085' - 4199' with 300 sx. Premium Plus. Tag at 3949'. Drill out cement from 3748' to 4010'. Drill out cement retainer and cement to 4203' Drill CIBP cement fill to 4214'. Drill junk from 4214' - 4228' x circulate clean. Drill new formation from 4229' to 4260' x circulate clean. Run neutron log from 4228' - 3000'. RU Schlumberger x perforate at 4206' - 4220' and 4187' - 4200', 2 JSPF. Set packer at 4120' x acidize new perfs with 1300 gal. 15% PAD acid. RU swivel x drill junk, iron sulfide, & formation to 4260' x circulate clean. RIH with ESP assembly on 113 jts. 2-7/8" tubing (intake at 3672'). ND BOP x NU WH. Turn well over to production. RD x MO x clean location.
