10/31/08 Treated perms w/6000 gals 20% HCL acid. Swabbed all water.

11/21/08 Ran 2-7/8" polylined tubing & 7" Arrowset I nickel coated injection packer. Circulated packer fluid. Set packer @5788'. Tested casing & packer to 650 psi. Held. Checked injection rates @1 BPM & 400 psi, 2 BPM @700 psi. Shut well in. Wait on injection facilities.
