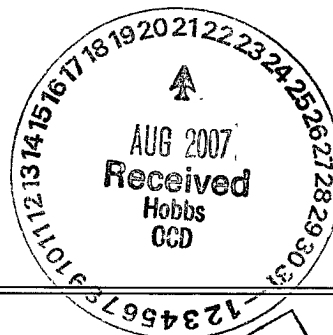

The Pipeline Deep 7 Fed Com 2 well was originally completed in the Quail Ridge; Morrow (Gas) pool in 05-2006. In October 2006, recompleat operations commenced, and the Morrow zone was covered by a CIBP. Effective 11-25-06, the well began producing from the Quail Ridge; Bone Spring oil pool.

Because the spacing unit changed from an E/2 320 acre Morrow gas spacing to a NE/4SE/4 40 acre Bone Spring oil spacing, there is no longer a need for the well to be part of Communitization Agreement NM-82537.

Therefore, Cimarex is changing the name of the Pipeline Deep 7 Fed Com 2 to **Pipeline Deep 7 Fed 2**.
