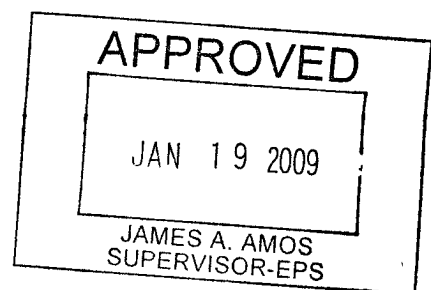

Marbob Energy Corporation has applied a protective carboline plasite conductive coating to the fiberglass tank(s). This coating is gray in color, but will reduce static electricity. This, in turn, will reduce the chance of the tank(s) being struck by lightning and prevent loss of fluids.
