The above well spud on November 18, 2008 and drilled a 12 1/4" surface hole to surface casing total depth of 1487'. Ran 8 5/8" 24# casing and set at 1476'. Cemented w/lead-440 sxs 'C' and tail w/200 sxs 'C'. Circulated to surface. Continued drilling 7 7/8" production with no incidents to total depth of 7136'. Ran open hole logs and prepared to run production casing. Ran 5 1/2" 17# casing and set at 7126.7'. Cemented w/lead-800 sxs 'C' and tail w/350 sxs 'C'. Circulated to surface. Rig Released on 11/30/08.
