Cemented w/lead440 sxs (12.9# 1.81 yield) and tail w/200 sxs (14.8# 1.35 yield). WOC. Drilled out and continued drilling 7 7/8" production hole to 7144'. Ran 5 1/2" 17# casing and set at 7134'. Cemented w/lead-900 sxs and tail w/350 sxs. Circulated to surface. Rig released on 1/18/2009.
