RIH and set RBP @ 3000'. Fill 5.5" with 2% KCl water. MIRU wireline unit to run temperature survey while injecting. Hook up to surface casing/production casing annulus (bradenhead valve) and begin injecting 10# brine and establish injection and rate (not to exceed 1800 psi and/or 3 bpm). Once injection rate and pressure have been established, run temperature survey. SD injection and POOH w/survey. Evaluate survey for injection interval.
