DO NOT RELEASE. Power pole, power control box, conduit, suction hose, and barbed wire north of well. Flowline on north side needs to be removed also. Depression on NE corner needs to be back filled. 1st letter of non-compliance. MW

Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well.
