ConocoPhillips Company respectfully request to recomplete the above well to the Blinberry O&G (6660) and the Warren Tubb (63280) pools.

The intent is as follows:

Drill Out CP from 3861-4100' and test the San Andres squeezed perms 4680-4685'. Continue to drill out plug at 5153-5400 to top of cement at 6947'. Perf the Tubb formation from 6440-6627 (4 spf/80 Holes) and Blinberry formation from 5835-6075' (4 spf/140 holes). Stimulation work of the above perms may occur depending if commercial and sustainable production is established.

Pending all partner approval, the intent is to have the work done by December 1, 2009.

We are respectfully requesting to extend the current TA approval from March 30, 2009 to December 1, 2009.
