Flowline from battery has leaked south of entrance to well. No report of operator filing C-141. NEED TO SUBMIT C141 AND DETERMINE VERTICAL AND HORIZONTAL EXTENT OF CONTAMINATION. SUBMIT REMEDIATION PLAN TO LARRY JOHNSON IN THE HOBBS DISTRICT OFFICE WITHIN 30 DAYS. Took picture. 1st notice. MW

Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well. Such a hearing may result in imposition of CIVIL PENALTIES for your violation of OCD rules.

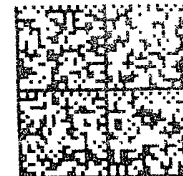
