**Operating and Maintenance Procedure:**

- Submit form C-144 CLEZ to Oil Conservation Division (OCD) to obtain permit to set steel tank at well location. The tank will be used to collect fluid during workover.
- When permit is obtained from the OCD the steel tank will be set at the well location prior to work performed (without any type of line).
- Operator will do daily visual tank inspection to locate any leak that might cause soil or ground water contamination.
- If a leak is detected the OCD will be notified immediately.

**Closure Plan – based upon the appropriate requirements of Subsection C:**

- Solids and Fluids will be removed from steel tanks and hauled off by trucking companies.
- The trucking company will take the Solids and Fluids to the closest approved public disposal: See C-144 Form – Controlled Recovery, Inc. – Disposal Facility Permit No. R-9166.
