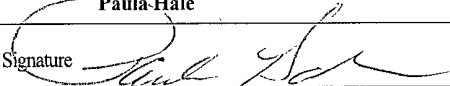

Pressure has been monitored on the subject well since plugging procedures were completed on June 18, 2008, as agreed to by the BLM and Range Operating New Mexico, Inc. Attached is a print out of the field data collected and input directly into our production system by Range field personnel. Well pressure ceased between February and May 2009 and has remained at zero. It is Range Operating New Mexico, Inc.'s intention to install the dry hole marker on the well head and officially plug and abandon the Eva Blinebry B #5.
