EUMONT YARD AGREEMENT

Whereas Dale "Tuffy" Cooper & Betty Cooper, husband & wife and the Dale Cooper Family Trust are the current surface owners ("Surface Owners") of that certain tract of land commonly known as the Finley Resources Inc. ("Finley") Federal D #12 wellsite. This site is located on the Bureau of Land Management Oil and Gas Lease number NM-18264 and is a tract approximately 200' x 150' in the NE/4 NE/4 of Section 27-20S-36E in Lea County, New Mexico.

Whereas Finley is the current operator of NM-18264 and is desirable of using the Federal D #12 wellsite as a storage yard to store non hazardous oil field equipment and supplies within the boundaries of said Federal D #12 wellsite.

Now therefore the parties hereto do hereby agree and confirm that for the consideration for \$500 per year, Finley Resources Inc. shall be permitted to store its non-hazardous oil field equipment, including but not limited to pipe, separators, tanks, pumping units and other standard oil field equipment, (other than drilling rigs) within the boundaries of the Federal D #12 wellsite. Finley shall indemnify Surface Owners from all liabilities associated with the storage of said equipment on said site. Finley agrees to pay any damages associated with the use and operation of the storage site. Finley will maintain the site in an orderly manner.

The term of this agreement shall commence on March 1, 2009 and shall continue for a period of four years or until March 1, 2013. The annual rental payments shall be payable on or before March 1st each year.

This agreement when executed by both parties will become a binding agreement and shall inure to the benefit of the successors and assigns of the parties hereto.
