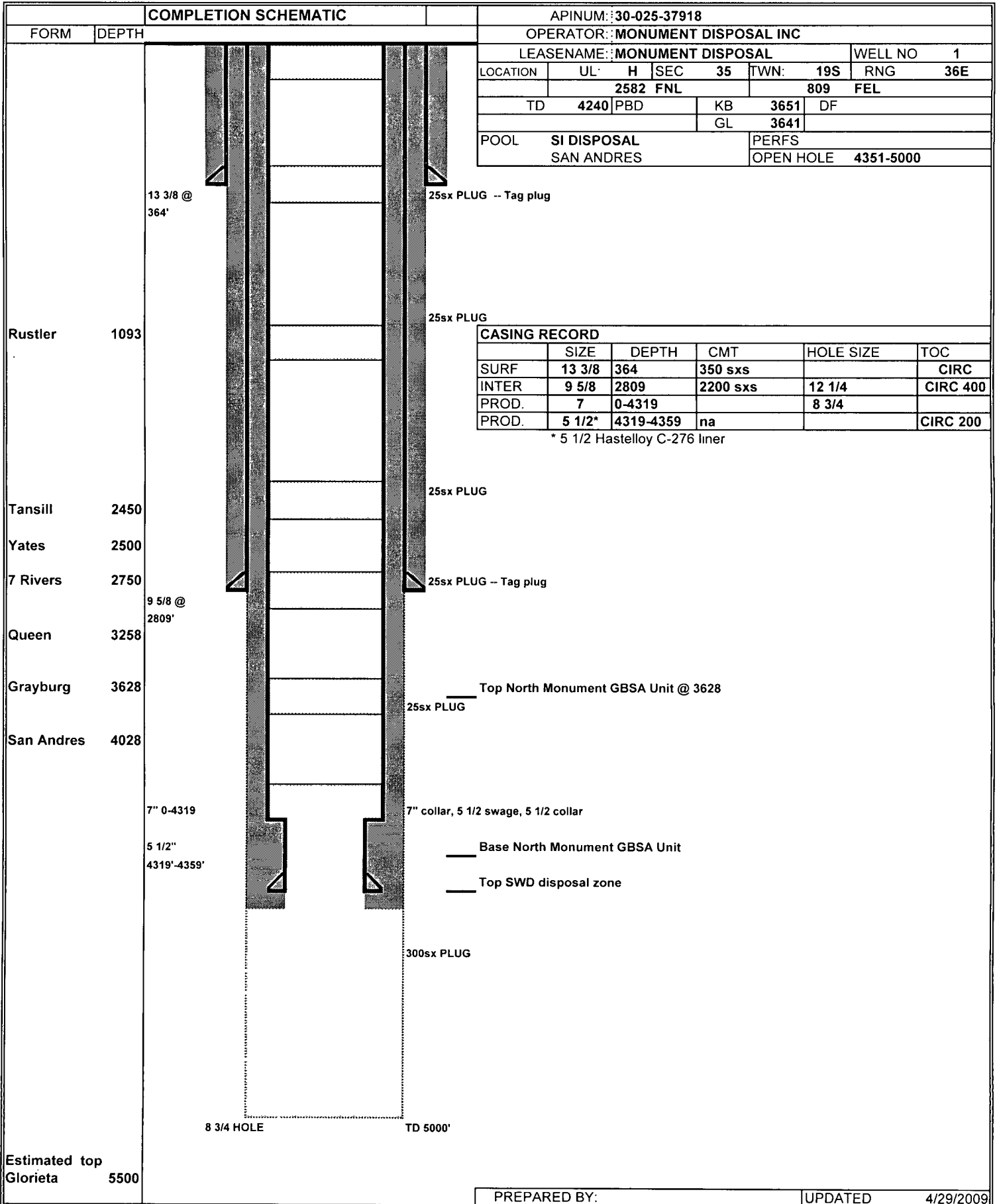

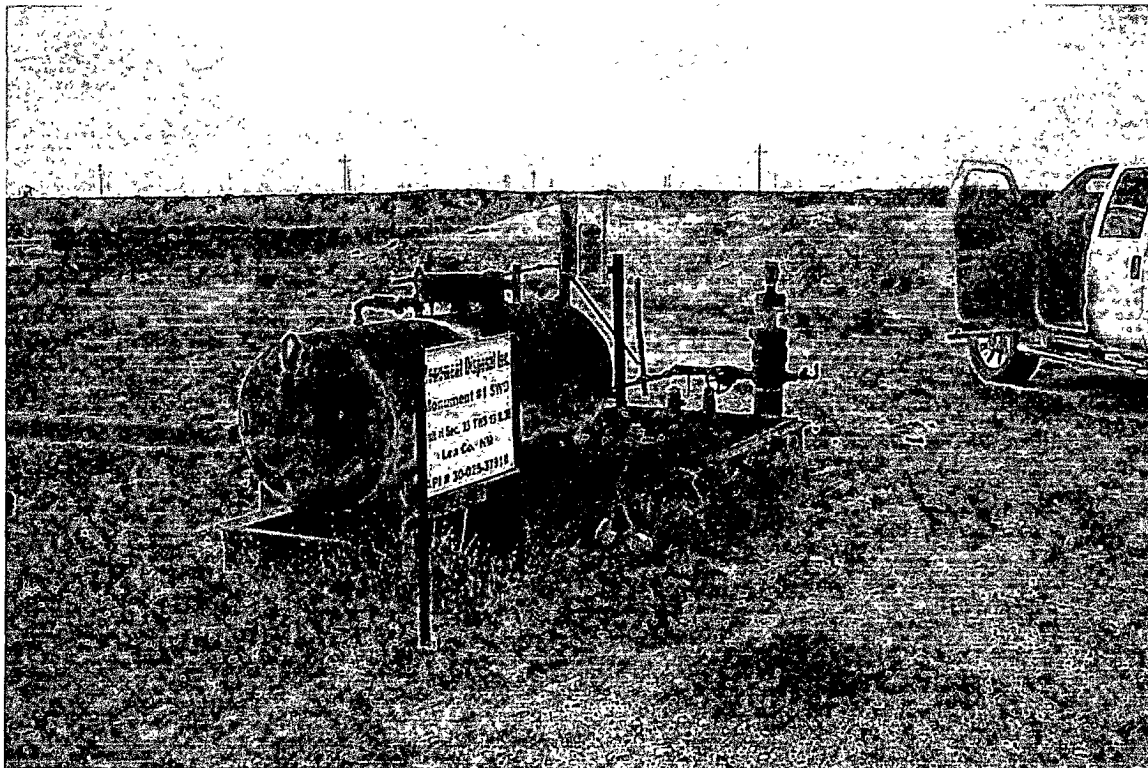
PROPOSED P&A WELLBORE SCHEMATIC AND HISTORY
