5/12/2009	RU plugging unit. Notified Maxey Brown, NMOCD of plugging operations.
5/13/2009	POH with packer and tubing. Set CIBP at 2,940'. Circulated hole with 10# mud. Pumped 25 sxs cement on top of CIBP.
5/14/2009	Tagged CIBP. Pumped 50 sxs cement on top of CIBP as instructed by Maxey Brown. WOC 4 hrs. Tagged plug at 2,790'. Pumped 25 sxs cement from 2,253' to 2,012'.
5/15/2009	Tagged plug at 2,003'. Perforated at 1,400'. Pumped 25 sxs cement from 1,443' to 1,202'. WOC. Tagged plug at 1,235'. Perforated at 460' and pumped 120 sxs cement to surface.
