12/17/08 Circulate 80 bbls gelled plugging mud.

12/19/08 Set CIBP @ 11,330' w/ 35' cmt to PBTD @ 11,295'.

12/19 - 01/05/09 Cut 5-1/2" production csg @ 11,130' and remove.

01/06/09 Set CIBP in 9-5/8" csg @ 11,100' w/ 35' cmt to PBTD @ 11,065'.

01/07/09 Run CBL to determine TOC behind 9-5/8" csg @ 9,200'.

01/09 - 01/16/09 Perforate 9-5/8" csg w/ 4 squeeze holes @ 9100'. Set CR @ 9036' Circulate 1255 sx cmt.

01/19/09 Tag PBTD @ 8994'. Run CBL. Determining TOC behind 9-5/8" csg @ 7000'. Run CNL/GR.

01/20/09 Perf Delaware @ 8110-20', 2 JSPF and 8338-48', 3 JSPF (50 holes).

01/21/09 Acid Delaware w/ 2500 gals 7% HCl.

01/23/09 Frac Delaware w/ 66K gals SS-2500 pad and 145K # sand.

01/28/09 Land sub pump @ 8414'. Place well on production from the Delaware.
