Comments on Inspection: DO NOT RELEASE. Well plugged in June 2008. Rule 19.15.25.10 calls for restoration on plugged wells to be completed within 1 year of plug date. NEED TO CUT OFF WELLHEAD, INSTALL DRY HOLE MARKER, AND LEVEL LOCATION. 1st notice of non-compliance. MW

Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well. Such a hearing may result in imposition of CIVIL PENALTIES for your violation of OCD rules.

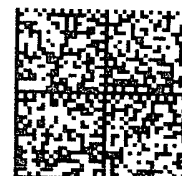
