Well sign not legible (Rule 19.15.16.8). Empty chemical drums, oil cans, oil filters, buckets with oil & water, and other debris north of unit (Rule 19.15.10.8). NEED TO REPLACE WELL SIGN AND REMOVE DRUMS, BUCKETS, CANS, AND DEBRIS FROM LOCATION. 1st notice of non-compliance.
